1. FY25 Service and Budget Planning update (Erin)

Erin gave a high-level summary to the TRAC committee about public input and upcoming service and budget planning.

2. Winter Weather Discussion (Lewis / Ben)

Lewis reported to the committee on winter weather planning. DART's approach is to look out a week ahead to determine public communications and a plan to maintain as much service as possible. Lewis encouraged the committee to take our communications seriously – if streets are not cleared, DART may have difficulty getting to the customers. ABC. Always Be Communicating. Anticipate when there is snow that there will be delays.

- Brandon expressed concerns over passengers being unable to access the bus stop and operators not being proactive about looking for those passengers.
- Both Brandon and Matthew shared that the bus had passed by them while they were standing at a stop due to the amount of snow at the stop.
- Matthew expressed pros and cons concerning operator practices in winter weather.
- Kaylynn expressed concerns over what should be done if the bus stop is inaccessible.
- Laurie commented on how cheerful the operators were on January 15, during the snow event.
